# MANAGEMENT REPORT TO ECKVILLE TOWN COUNCIL March 28, 2022

### **Current Activities:**

- Highway 11 Twinning, Functional Planning Study Highway to Township Road 390 (east of Benalto): We are still waiting for notice of the next Stakeholder Meeting.
- Water Pump House Upgrade Project: According to our Engineers the final deficiency items are being completed. The fuel tank (from the old generator) and the old electrical cabinets have finally been removed from the pump house and the new flow meter for the backwash system should have been installed late last week. We will now start the task of cleaning and painting the inside of the pump house building, installing a new workstation and counters for water testing. It has been a long slow process, but we are finally nearing completion.
- <u>Snow Removal</u>: The public works crew continues to work at plowing snow throughout Town. We understand that Council would like to review and discuss this policy at our upcoming strategic planning session.

### **Future / Planned Activities:**

- ICS200 Course: It is our understanding that another ICS200 course may be offered in the
  next month or two. If possible, we will try to have one or two of our Employees attend. As
  previously noted, ICS I-200 enables personnel to operate efficiently during an incident or
  event within the command system.
- Stantec Report on Wastewater Treatment Options: We finally managed to contact Stantec and hope to have an update for you at the meeting on April 11<sup>th</sup>.
- <u>Structural Inspection of Old Eckville Water Tower</u>: We have been waiting to hear back from Stantec regarding a structural inspection of our old water tower. We were able to find a set of original drawings for the structure when it was erected and a copy of them have been provided to Stantec to assist them with their inspection. We would expect them to move ahead with the inspection in the next month or so.
- <u>Year End Audit</u>: The auditors have almost completed their field work. We are on track to present financial statements to Council by April 25<sup>th</sup>.
- <u>Strategic Planning Discussions</u>: We are hoping to conduct our own strategic planning session this year. We would likely build on the plan from the last session which was held on February 19, 2020. We look forward to making a decision on how to conduct this session and what date to hold it on. It should be in advance of our final 2022 budget presentation.
- **2022 Operating and Capital Budget**: We would like to talk about a possible date to present our 2022 Operating and Capital Budget at the March 28<sup>th</sup> council meeting.

### Management Report - March 14, 2022

- <u>Term of Reference and Bylaw for Medical Committee:</u> Administration is still working on a Bylaw to create a "Medical Committee". This bylaw will include a term of reference for the proposed committee and proposed membership.
- <u>Nurse Practitioner Project</u>: At the writing of this report we have still not heard back from Lacombe County on their decision on our request for three year funding for this project.
- <u>Municipal Breakfast</u>: The Municipal Breakfast is scheduled for May 7<sup>th</sup>. Save the date on your calendars.
